The Design Department

The principle function of the design department is to design and develop Bootliners, using a laser scanner, 2D and 3D CAD modelling software to create patterns to match specific vehicle requirements. The department works closely with Commercial, Marketing and Production to fulfil commercial demands.

The Goal is to expand the capacity of boot liner designs to keep pace with an increasing demand.

The Role

The role of the Product Designer

1. Product Design:

- Understudy to the design team learning the skills required to design a bootliner
- Increase the efficiency of boot liner design
- Learn the use of Solidworks design software and/or other appropriate design software
- Learn techniques to rapidly and accurately scan car boots with a 3D laser scanner to facilitate boot liner design.
- Ensure that designs are approved internally and externally to successfully meet orders.
- Product Research

2. Commercial Support:

- Support product design with marketing photos and text
- Support product design with supplementary documents
- Support digital marketing with uploads to website
- Be responsible for the administration and communication between Design and the Commercial and Production departments
- Technical support to customers via telephone



The role will be office based for the majority of the time, however, some travel from time to time may be required.

Accountabilities

- Building and maintaining processes with customers, marketing and production
- Acting as a point of contact between the clients and the Design Department.
- Carrying out other necessary administrative duties in the Design department.

Responsibilities

- Ensuring a smooth flow of boot liner approvals from the initial customer into the Design Department.
- Working with various design software to improve new designs, or improve existing bootliner designs.
- Will be involved in planning and scheduling of prototypes in order to maximise the efficiency and productivity of Design Department.
- Communicating effectively with customers and other areas of the business via email, verbal and written communication.

 happens informally, face to face and using email.
- The PD will also have a regular and frequent communication with the Design Manager/ Commercial Department.
- The PD will liaise with THC Quality Environment H&S Manager, THC PVC Sewing Department and THC PVC Cutting Department and employees regarding daily communication on an informal basis to ensure the suitability of new designs for manufacturing purposes.

Service Provider Interfaces

- THC Commercial Department: This departmental interface involves occasional communication on an informal basis concerning targets, standards and issues which require daily involvement.
- THC PVC Cutting/Welding & Sewing Departments: This is an informal and infrequent interface relating to specific designs, prioritisation and quality.
- THC Quality Environment H&S Manager: This is an informal and infrequent interface concerning specific quality standards being maintained in a timely manner.
